

<u>Justice for Girls</u> Internship Position Posted January 7, 2020

Justice for Girls (JFG) is looking for passionate and committed young women, 16 - 24 years old, who have lived experience of poverty, life in government care, and/or homelessness to train as Interns with our organization.

Justice for Girls promotes social justice, and the health and wellbeing of teenage girls who are low income, marginalized or homeless in British Columbia. We advocate for teenage girls and work to enhance laws, policies, and practices that promote and protect girls' rights to safety, dignity, and equality. We also advocate for young women to be at the forefront of law, policy, and programs affecting their lives.

The 5-month full-time internship is available to young women who are interested in achieving a high school graduation certificate and are working to complete their grade 12 course credits. In collaboration with the Vancouver School Board, interns can earn course credits in addition to their wage. Young women who have completed high school graduation are also encouraged to apply.

The Internship will include:

- **Training.** Interns will receive training in:
 - Women's and girls' equality rights;
 - Social justice and injustice issues sexism, poverty, racism, colonialism, homophobia, violence, homelessness and other forms of discrimination and the compounding impacts of these on girls lives;
 - Local, national and international laws, legislation, policies and systems which govern girls lives;
 - Advocacy and alliance building;
 - Public speaking and writing; media interviews;
 - Research and data analysis;
 - Peer mentorship; and
 - Workshop facilitation.
- > Research and Analysis. Interns will:
 - Research and analyze current programs, services and reports
- > Increasing Public Awareness. Interns will:
 - Share their learning through public speaking/writing, media interviews, blogs, art;
 - Contribute to the production of educational materials and resources;
 - Co-lead youth educational and empowerment workshops and groups; and
 - Contribute to professional development workshops.
- > Engaging Community and Effecting Social/Systemic Change. Interns will:
 - Build partnerships to promote girls' rights within policies and programs
- > **Court Monitoring.** Interns will:
 - Observe and monitor cases involving young women and girls
- > Justice for Girls' Center project. Interns will:
 - Contribute to the development of a Justice for Girls' Center to be piloted in Vancouver
